### **Schedule for Production**

Please produce the following records in the possession, custody, or control of the Pennsylvania State Police (PSP), or any personnel thereof, in unedited and unredacted form:

1. All transcripts and recordings from interviews conducted by PSP related to the attempted assassination of Donald J. Trump on July 13, 2024, in Butler, Pennsylvania (hereinafter, the July 13 event).
2. The mobile video recorder footage from Trooper Neugebauer's squad car on July 13, 2024, as well as any other recorded audio or video related to the July 13 event.
3. All body worn camera footage from PSP personnel related to the July 13 event.
4. Any recordings of PSP radio communications related to the July 13 event.
5. All internal inquires, investigations, and/or reports that have been completed by PSP related to the July 13 event, including, but not limited to, all related and underlying documents and information that are referred to in, or were used to compile, those inquires, investigations, and/or reports.
6. A list of all internal PSP inquiries, investigations, and/or reports that are planned or ongoing related to the July 13 event, including but not limited to list of all PSP use of force and/or officer involved shooting inquiries, investigations, and/or reports, and a list of the targeted completion dates for such inquiries, investigations, and/or reports.
7. All documents relating to any criminal inquires, investigations, and/or reports that have been completed by PSP related to the July 13 event, including, but not limited to, all related and underlying documents and information that are referred to in, or were used to compile, those inquires, investigations, and/or reports.
8. A list of all PSP criminal inquiries, investigations, and/or reports that are planned or ongoing related to the July 13 event, and a list of the targeted completion dates for such inquiries, investigations, and/or reports.
9. All use of force and/or officer involved shooting inquires, investigations, and/or reports that have been completed by PSP related to the July 13 event, including, but not limited to, all related and underlying documents and information that are referred to in, or were used to compile, those inquires, investigations, and/or reports.
10. Any written policies relevant to the July 13 event, including but not limited to policies or procedures related to use of force and/or officer involved shooting inquiries, investigations, and/or reports.
11. Any communications, including emails, text messages, phone logs, or communications from other messaging services related to the July 13 event, including but not limited to

both internal PSP communications and external communications with other state, local, and federal law enforcement entities.

12. Any operational plans or other materials prepared by PSP in advance of the July 13 event.
