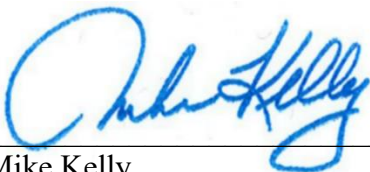
Dear Secretary Mayorkas and Acting Director Rowe:

Pursuant to the authorities set forth in House Resolution 1367, as amended by House Resolution 1470, the Task Force on the Attempted Assassination of Donald J. Trump (Task Force) hereby requests the documents and interviews identified in the accompanying Schedule by October 11, 2024.

The Task Force is investigating all actions by any agency, Department, officer, or employee of the federal government, as well as State and local law enforcement or any other State or local government or private entities or individuals, related to the attempted assassination of Donald J. Trump on July 13, 2024, in Butler, Pennsylvania (hereinafter, the July 13 event) and on September 15, 2024, in West Palm Beach, Florida (hereinafter, the September 15 event).

Thank you for your prompt attention to this request. On behalf of the Members of the Task Force, we appreciate your full cooperation in advance.

Schedule for Production

Please produce all records in the possession, custody, or control of DHS, USSS, or any officer or employee thereof, in unredacted form:

1. Any briefing materials, written testimony, prepared remarks, and handouts prepared for and/or provided to Members of Congress or congressional staff during, or in connection with any hearings, briefings, press events, or any private or public events referring or related to the September 15 event, including the timeline of events as described during a briefing for Task Force members and staff on September 18, 2024. This request remains ongoing and includes any documents and information provided to Congress in any subsequent production made by DHS and USSS after receipt of this letter. Any such subsequent production shall be produced to the Task Force in a concurrent manner
2. A duplicate copy of all documents, communications, and materials produced to the Federal Bureau of Investigation (FBI) to date referring or related to the September 15 event, including any reports of investigation. This request remains ongoing and includes any documents and information provided to the FBI in any subsequent production made by DHS and USSS after receipt of this letter. Any such subsequent production to the FBI shall be produced to the Task Force in a concurrent manner.
3. All transcripts from interviews conducted by DHS and USSS related to the September 15 event.
4. An organizational chart showing the structural chains of command between or among all USSS divisions and teams (i) involved in or contemporaneously aware of the planning of former President Donald J. Trump's protectee schedule for September 15, 2024, and (ii) who were present at the September 15 event, including subgroups within the Special Operations Division.
5. A list of all internal inquiries and/or reports that are underway within DHS and USSS related to the September 15 event, and a list of the targeted completion dates for such inquiries and/or reports. Please provide any such reports that are final, including but not limited to any Unusual Protective Event (UPE) report and the Mission Assurance Review (MAR).
6. The following information referring or related to the USSS's security plan for an off the record movement of a candidate for President and of a former President:
 - a. Any written policies or procedures, including with respect to the establishment of security perimeter(s) and the allocation of responsibility between USSS and state and local law enforcement partners with respect to those perimeter(s), and any documents or materials reflecting enhancements or changes with respect to such policies or procedures as a result of the September 15 event;

- b. Any written security plan for September 15, 2024, including but not limited to securing the perimeter of the Trump International Golf Club in West Palm Beach, Florida;
 - c. The protective methodology used for a protectee on a golf course, and any documents or materials reflecting enhancements or changes with respect to such methodology as a result of the September 15 event;
 - d. A complete list of non-DHS and non-USSS entities present at the September 15 event, including, but not limited to, other federal agencies, state law enforcement entities, and local law enforcement and emergency services entities;
 - e. Any communications, including emails, text messages, phone logs, or communications from other messaging services related to USSS's overall security plan on September 15, 2024, including with respect to securing the perimeter of the Trump International Golf Club in West Palm Beach, Florida; and
 - f. A list of DHS and USSS personnel responsible for the USSS's security plan on September 15, 2024.
- 7. A copy of all recordings and logs of radio transmissions related to the September 15 event.
- 8. The following information referring or related to the USSS's intelligence advance process:
 - a. Any communications, including emails, text messages, phone logs, or communications from other messaging services related to USSS's intelligence advance process in connection with former President Donald J. Trump's schedule on September 15, 2024;
 - b. All documents and communications relating or referring to security breaches, vulnerabilities, risks, concerns, and assessments with respect to Trump International Golf Club in West Palm Beach, Florida;
 - c. A list of credible threats to former President Donald J. Trump that were considered active, ongoing, or unresolved on September 15, 2024, regardless of whether such threats were specific to Ryan Wesley Routh or the September 15 event, and regardless of when such threats originated, based on intelligence developed by any federal agency and shared with the USSS as of the September 15 event; and
 - d. A list of DHS and USSS personnel responsible for the USSS's intelligence advance process for September 15, 2024.
- 9. The following information referring or related to the USSS's communications structure for an off the record movement of a candidate for President and of a former President:

- a. Any written policies or procedures, including with respect to communications with state and local law enforcement partners and with respect to the quantity, composition, and interoperability of USSS and state or local law enforcement command posts, and any documents or materials reflecting enhancements or changes as a result of the September 15 event;
 - b. Any written USSS communication plan on September 15, 2024; and
 - c. A list of DHS and USSS personnel responsible for the USSS's communications structure on September 15, 2024.
- 10. The following information referring or related to the USSS's Counter-Unmanned Aerial Surveillance (C-UAS) capabilities:
 - a. Any communications including emails, text messages, phone logs, or communications from other messaging services related to the deployment of USSS C-UAS systems on September 15, 2024; and
 - b. A list of DHS and USSS personnel responsible for deployment decisions of USSS C-UAS systems on September 15, 2024.
- 11. A list of all changes to USSS policies and procedures since the September 15 event, as well as new policies and procedures that have been implemented since the September 15 event.
- 12. All communications, including emails, text messages, phone logs, or other messaging services, referring or related to the planning and security of former President Donald J. Trump on July 13, 2024, at the Butler County Farm Show fairgrounds rally between or among USSS and FBI.
- 13. All communications, including emails, text messages, phone logs, or other messaging services, referring or related to the planning for and security of former President Donald J. Trump on July 13, 2024, at the Butler County Farm Show fairgrounds rally between or among DHS, including but not limited to Homeland Security Investigations (HSI), and FBI.
- 14. All communications, including emails, text messages, phone logs, or other messaging services, referring or related to the September 15 event, between or among USSS and:
 - a. DHS, including contractors;
 - b. Homeland Security Investigations (HSI);
 - c. FBI;
 - d. State law enforcement entities;

- e. Local law enforcement entities;
 - f. Emergency services entities;
 - g. Donald J. Trump for President 2024, Inc.;
 - h. Trump International Golf Club, West Palm Beach; and
 - i. the White House.
15. All documents and communications referring or relating to the September 15 event, including but not limited to the following:
- a. Logistics, including perimeter and boundary information for Trump International Golf Club in West Palm Beach, Florida;
 - b. Counter Surveillance;
 - c. Incident Reporting Protocols;
 - d. Intelligence information;
 - e. Command post log;
 - f. USSS memoranda; and
 - g. Memoranda of Understanding (MOUs) between DHS or USSS with other federal agencies.
16. All (i) U.S. Customs and Border Protection and (ii) DHS, HSI documents, records, memoranda, interviews, communications and materials referring or related to Ryan Wesley Routh, including but not limited to the following:
- a. Tips, allegations, and reports of concern and/or suspicion;
 - b. Investigations of tips, allegations and reports of concern and/or suspicion;
 - c. Referrals of such tips, allegations and reports of concern to other federal agencies and local law enforcement entities; and
 - d. Decisions to refuse or decline such investigations and/or cases.

Schedule for Interviews

Please make available for transcribed interviews the officers and employees of the Department of Homeland Security (DHS) and/or the U.S. Secret Service (USSS) who served in the following roles during, or in preparation for former President Donald J. Trump's USSS detail on September 15, 2024:

1. USSS Local Field Office Special Agent in Charge.
2. USSS Donald Trump Protective Division Special Agent in Charge.
3. USSS Special Agent who discharged their firearm on September 15, 2024.

Please also communicate to the Task Force if individual USSS personnel fit more than one category described in this section.
